Dear Friends

Since April-2004, with your patronage NICE has indeed come a long way! During our first year 2002-03, contributions to NICE was 2.37 Lakhs, In 2003-04 4.23 Lakhs registering a growth of 80%. During 2004-05, we crossed Rs 10 Lakhs registered a phenomenal growth of 140% and this year 2005-06 we exceeded our target by achieving 13.19 Lakhs. Thanks again for your immense efforts.

The school now houses 60 students, 01 Headmaster, 05 qualified teachers, 02 cooks and 01 Administrative assistant. This academic year, we will add 25-30 orphan children, 02 qualified teachers and 01 aiyah. During enrollment into 06th standard, we noticed that the students lacked even the knowledge of a 02nd standard student and we had to start training them from 02nd standard CBSE syllabi. The children have been showing consistent improvement in studies, general knowledge, reading skills, sports and extra-curricular activities. The students also have shown interest in playing Volleyball & Cricket regularly.

The most important milestone in the past year is that NICE was able to attract and recruit qualified teachers and more corporate donations. ASHA's volunteers from Berkeley (USA) have been supporting us since Apr-04. Organizations like Computer Associates, Microsoft India R&D Pvt Ltd, Invensys Developmental Center India Pvt Ltd, Sri Sai Sankalpa Seva Trust, ASHA-Wah Project, Start Foundation, Polymon Instruments Pvt Ltd,

We also added 1800 sqft to the school building, taking the total built area is around 3800 sqft (RCC), 400 sqft (Asbestos roof) and 500 sqft (Thatched roof), and can comfortably house 90 students along with staff and teachers.



