Dear Friends

Please accept our heartfelt thanks to every one who have supported NICE during the past 7 years. Our progress from 10 children (2003) to 115 children today is because of this amazing encouragement and support from donors like you. We have also been able to increase our school infrastructure from 400 Sqft (2003) to 12,000 Sqft. What is significant is the fact that most of the donations are from individuals unlike many other schools like us.

This year there were few students from NICE who have written their 10th class public examination in NIOS board (National Institute of open Schooling, Ministry of Human Resource Development, Government of India). It is also a fact that NICE is probably the only fully free residential high school in Andhra Pradesh offering CBSE (English medium), providing free food, education, health and shelter for poor orphans, single parent children, and underprivileged children.

From a modest 2.37 lakhs contribution during April-2002 to March-2003, we were able to raise 34.16 Lakhs this year 2008-09. NICE has been able to demonstrate that up to 97% of the donation is spent entirely for the children and their education, shelter and nutritious food. A mere 3% towards administrative expenses is undoubtedly the lowest in this category of schools, which rely on individual donations. We also have been acclaimed as one of the best governed NGOs in terms of our transparency in accounts and financial management. Organizations like Intelligroup Asia, Pvt. Ltd, NATCO Trust, Cognizant Technologies Ltd., Invensys, Asha, Helping Indians, etc. have visited NICE and appreciated our work and contributed towards development of NICE, particularly in the areas of improving children academics and infrastructure. NICE also received the permission from the Ministry of Finance to accept foreign contributions, under the FCRA act.

As it has been in these past seven years, none of our board members have claimed a single rupee so far and are committed to serve free. As the only full-time board member with NICE, I too have not drawn a single rupee as salary. However, I am supported by friends and well wishers like volunteers from 'Asha for Education - USA' - Mr. Abhilash Nama, Mr. Kashyap, Mr. Deep Karan, Mr. Sreekanth Voorakaranam and Mr. Karthikeyan, Mr. Prasanna Kumar, Mr. Giri Kolanupaka, Karidala Phanindra and 'Bibo Water'. I would like to convey my special thanks to 'Bibo Water' for having supported me by extending honorarium to my family since 2002 as I refused to draw salary from NICE. I am also thankful to Silver-Oaks school founder, Mr. Dhanunjaya and Principal, Mrs. Seetha Murthy, to have extended to provide free schooling for my two children.

This academic year (2009-10) we plan to add 25 more children, increasing our school strength from 140 to 145 and to add two teachers increasing the strength to 10 teachers. We have always kept the student to teacher ratio low so as to deliver quality education and support to students. As the teachers were finding it hard to find housing in nearby villages, the school has been providing residential units to stay within the campus and can accommodate (24/7) a couple of visitors. We have also added another 300 books to the library this year increasing to a total of 800 books, including 10 kinds of monthly magazines and 3 different daily newspapers. The children have welcomed this facility and are encouraged to spend at least one hour in the library every day.

NICE is extremely grateful to Mr. G.V of IdleBrain and Mr. Stalin of Radio City for having publicizing NICE through their media (website and radio). They were able to spread the message across USA while interviewing Mr. Radha Krishna (successful movie director), who declared NICE as one of his inspirations during making the movie 'Gamyam'.

Our thanks to Asha volunteers to have raised money under their 'Asha Work An Hour (WAH)' initiative which took care of our teachers salaries. Our sincere thanks to other corporate companies like Intelligroup, NATCO Trust, Helping Indians, HBL Power Systems Ltd., SVS Projects, Samida Group, Invensys Development Center, Embedded InfoTech Ltd, Hyderabad Educational Academy, IndMax IT Solutions Pvt Ltd. About the School

Our 'NICE' school is located in Mynampadu village, Kanaparthy Panchayat, a remote village between Narsaopet and Chilakaluripeta in Guntur district of Andhra Pradesh, India.

Admission process

We admit students in to the school between the 5th and 10th Standard under the CBSE system. These students are typically school dropouts who are orphans or bonded labor children or single parent children and are admitted in the school without any payments. We thoroughly check the applicant background to ensure only eligible and deserving students are selected.

Students Profiles

The current student strength is 115 and is expected to reach 140 during this academic year. Here are a few profiles of our students:

Dhulipala Narendra: Is an orphan from Minnakallu village, Prakasam District. Convinced on his keenness to continue studies, we admitted him in 5th std. He likes the school, the teachers, and friends in this school.

Battula Ravi: Is from a village named 'Vittamraju Palli', Guntur Dist and an orphan from a very poor family. Someone from the same village brought him to our school and we admitted him in 5th standard last year. He has improved considerably in the last year in his academics. His aim is to study well and to serve the society after finishing his schooling.

Galla Mahendra Babu: An orphan from Nemalipuri village, Guntur Dist, he dropped out from the local village school. We admitted him last year in 5th std. He started liking the school. He says that he likes the food and our cook Ms. Padmamma, who takes a very good care of him apart from being a good cook.

Bellamkonda Rajashekar: An orphan from Ananthavaram village, he is very interested in education. He is also very studios and curious in trying innovative methods. At the time of joining us last year in the 5th standard, he was always moody and seldom smiled. Now, we see him smiling most of the times.

Nagaraju: A student from the first batch in NICE, he was admitted in the 6th standard, now pursuing his 10th standard. He has promised that he will pass his 10th std with very good marks. He also thanks Butterfly Edu Fields founder Mr. Sharath Chandra and Mr. Nikhilendra, IIT for their valuable tips in Mathematics and Sciences. After finishing our classes daily, he likes to and learn through playing and to learn different concepts.

The year ahead (2009-10) ...

There is a strong need and a huge demand to start a school exclusively for girls. We believe that the most needy and illiterate are the girl children. We hope to start a special school for girl children by 2010. However, we need to plan acquisition of land in this year. One of our goals this year is to raise Rs. 16 lakhs for this project in the coming year. Any suggestion or help to make this happen is most welcome.

We also need to equip the school with better science labs (physics, chemistry, botany and zoology) as per CBSE board specifications. The approximate cost for this is around Rs. 3 lakhs.
