



RULES AND REGULATIONS

1. NAME OF THE SOCIETY : Needy Illiterate children Education (NICE)

3. (i) MEMBERSHIP : 21 years age above

(ii) CATEGORY OF MEMBERS : General

(iii) ADMISSION FEE AND THE ANNUAL SUBSCRIPTION OR MONTHLY SUBSCRIPTION: 50/-
25/-

4. GENERAL BODY

(i) Annual General Body will meet once in a year i.e. in the month of May

(ii) FUNCTIONS:

- To pass the budget for the ensuring year and approve the expenditure statement of previous year.
- To approve the reports of the activities of the Society.
- To elect the Executive Committee etc.,
- To appoint Auditor.

5. (i) Executive Committee: Shall consist of seven (7) Members and out of them, the following of five bearers shall be elected by the E.C. Viz. President, Vice-President, General Secretary Joint Secretary and Treasurer and the remaining persons all the Executive Committee Members.

(ii) The members of the Executive Committee (Governing Body) shall be duty bound to atleast the signatures of all the members of newly elected Executive Committee and to see that the signatures of the out going Governing Body tally with the annual list as filed with the Registrar of Societies before 15 days the succeeding month in which elections were held.

(ii) FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS:

1. PRESIDENT:

He presides over all the meetings of the General Body and Executive Committee. He can cast his vote in the case a tie in decision making. He can supervise all branches of the Society.

2. VICE-PRESIDENT:

He shall assist the President in discharge his functions. In the absence of the President he will perform the duty of the President as entrusted by the President.

3. SECRETARY:

He is the Chief Executive Officer of the Society and Custodian of all records relating to the Society and correspondent on behalf of the Society. He has to take on record all minutes of the Society, would convene both the Executive Committee and General Body of the Society with the permission of the President. He guides the Treasurer in preparing the budget and expenditure statement to place before the General Body for its approval.

4. JOINT SECRETARY:

He has to do the work entrusted by Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of the Secretary, he can perform the duties of the Secretary.

5. TREASURER:

He is responsible for all financial transaction and Funds of the Society. He has to maintain accounts properly along with the vouchers. He has to prepare the accounts of the Society jointly with the Secretary or President.

6. OFFICE BEARERS:

They are responsible persons to attend to such activities of the Society which the Executive committee entrusts to them.

7. QUORUM:

Half of the total members for General Body meeting and 1/4 for Executive Committee meeting.

8. FUNDS:

The funds shall be spent only for the attainment of the objects of the Society and no portion thereof shall be paid to transferred directly or indirectly to any of the members through any means.

9. AMENDMENTS:

No amendment or alteration shall be made in the purpose of the Association unless it is voted by 2/3 of its members present at a special meeting convened to the purpose and confirmed by 2/3 of the members present and at a second special meeting.

10. WINDING UP:

In case the Society has to be wound up the property and funds of the Society that remain after discharging the liabilities shall be transferred or paid to some other institutions with similar aims and objects.


We draw your attention to our circular letter referred above wherein we have informed that HSBC Bank, New York informed that the cash letter facility for USDollar cheques will be discontinued from 29-11-2013. We have also informed you to convey the same to the branches under your jurisdiction advising them to bring it to the notice of their customers.

We have approached all our USD Nostro correspondents and requested them for USD Cash letter facility but they expressed their inability to offer the facility in view of the stringent regulatory issues pertaining to AML and KYC guidelines involved in the facility from US Federal Reserve. All the US banks who are hitherto offering this facility to other Indian Banks are also exiting the cash letter arrangements for the above reason and due to the inherent risks involved in collection of cheques.

Hence we inform that we will not be in a position to collect the cheques drawn in US dollars deposited by our customers in the branches from 28-11-2013. We advise all Zonal Offices and pooling centres to inform the branches under their Jurisdiction not to accept US dollar cheques from their customers for collection/purchase. Branches may be advised to inform their customers accordingly and request them to arrange for USD funds through SWIFT for remittances which is fast and cost effective as an alternative. The detailed procedure for SWIFT remittances is made available on our portal and website also.

In view of the above we request all the Zonal offices/Pooling centres/B category branches to inform accordingly their customers and ensure that cheques, if any received for collection from customers they are received by HSBC Bank well before 28th November, 2013. Please note that any instrument received after the 28-11-2013 is liable to be returned by HSBC.
